Nomination forms can be downloaded by visiting <u>aec.gov.au/ieb</u> and selecting the relevant election. Alternatively, additional nomination forms are available upon request from the Returning Officer.

Additional forms are available from the Returning Officer.

Prospective candidates and nominators should verify they meet all eligibility criteria set out in the organisation's rules, including financial status and any other necessary qualifications, before submitting their nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than** 10am (Australian Eastern Daylight Time (AEDT)) **on** 05/01/2026.

## How to lodge nominations:

Nominations must be submitted using one of the following methods:

- 1. **By portal:** Visit the Australian Electoral Commission Portal at <a href="www.aec.gov.au/ieb">www.aec.gov.au/ieb</a>. From this page, select "Access the electoral event portal," then click "Current industrial elections." Locate and select your election, then access the nomination documents.
- 2. **By email:** A fully completed nomination form, including all necessary signatures, may be scanned and emailed to <a href="mailto:lEBnominations@aec.gov.au">lEBnominations@aec.gov.au</a>.

#### PLEASE NOTE:

- 2.1 Nomination forms may be submitted as PDF files, with each candidate's form in a separate PDF.
- 2.2 When sending nominations via email, please use the subject line as: "AVBP9 E2025/136 Nomination [Name of candidate]"

#### **IMPORTANT INFORMATION ON EMAILS:**

- 2.3 Emails that appear to be spam may be blocked. It is the sender's responsibility to ensure their nomination email is delivered to the returning officer before the deadline.
- 2.4 Emails and attachments must not exceed 6 MB in total size.

## **Team Nominations**

As per Rule 36A(h), a team nomination must nominate the required number of people for each position in which nominations have been called. Each team nomination must have a team name. As part of the team nomination process, the team must identify one member of the team to act for and on behalf of the group in relation to the nomination ("the authorised person"). For more information, please refer to Rule 36A of the organisation's rules.

## **Nominations Close and Acknowledgment**

After nominations close, all submissions will be reviewed to ensure they meet the eligibility criteria and comply with the organisation's rules. If any issues are identified, the returning officer will notify the relevant candidates and provide a specific timeframe to remedy their nomination.

## Withdrawing Nominations

Nominations cannot be withdrawn after 10am (AEDT) on 14/01/2026.

## **Voting Period**

The ballot, if required, will open on 20/02/2026 and close at 9am (AEDT) on 19/03/2026.

#### **Scrutineers**

The appointment of scrutineers closes 9am (AEDT) on 19/03/2026. A form is available from the Returning Officer for the purposes of appointing Scrutineers.

## **Replacement Voter Pack**
